

Work Session/Landfill Committee/Board of Health Meeting
August 8, 2011

The Work Session of the Board of Commissioners was held on Monday, August 8, 2011 in the Commissioners Meeting Room at the Courthouse. Board members present were Chairman Frank Holman, Commissioner Dennis Giese and Commissioner Dave Potts. Others present were Director of General Administration Robert Christiansen, Director of Finance Dan Short and Deputy County Clerk Merrilou Cicerelli.

The complete Work Session was recorded on CD media. The following parts of the Work Session were held in a Regular Board of Commissioners Meeting format and would be subject to action minutes being taken.

Landfill Committee Meeting

Committee members present were Chairman Frank Holman, Commissioner Dennis Giese, Commissioner Dave Potts, Director of Finance Dan Short, and Land Manager Shannon Wilcox. Others present were Director of General Administration Robert Christensen, Deputy County Clerk Merrilou Cicerelli, County Attorney Jenny Davis and Bookkeeper Becky Venes.

Following the Pledge of Allegiance, Chairman Holman called the Landfill Committee meeting to order at 9:00 a.m.

Chairman Holman asked Deputy Clerk Cicerelli for verification regarding the distribution of the Board of Commissioners' Agendas. Deputy Clerk Cicerelli stated that the agendas were properly distributed.

Landfill Manager Wilcox presented his monthly report for July 2011.

Bookkeeper Venes presented the Landfill Statistics for the month of July 2011.

Commissioner Giese made a motion approve the Landfill Statistics for the month of July 2011. Commissioner Potts seconded the motion. On the question, the motion carried 5 - 0.

Mickey Berry, Angel of Shavano Recycling, presented his July 2011 report. He presented an update of what the current types of plastics that were now being sold and what was just trash.

Commissioner Giese made a motion close the Landfill Meeting at 9:17 a.m. Commissioner Potts seconded the motion. On the question, the motion carried 5 - 0.

Board of Health

Zack Zeiset, County Public Health, presented the Public Health's July 2011 report.

Victor Crocco, Chaffee County Environmental Health Manager, presented his report on program activities for June 2011.

County Development Services Director Don Reimer presented an overview of a continuing problem in Sand Park where resident Russell Drake has been reported to be sandblasting on his property. The neighboring property owners had filed complaints to the County.

County Attorney Davis advised contacting the Colorado Environmental Protection Agency for suggestions.

Health and Human Services

Commissioner Giese made a motion close the Health and Human Services Board regular meeting at 10:15 a.m. Commissioner Potts seconded the motion. On the question, the motion carried 3 - 0.
